Chancellor Eloy Ortiz Oakley issued a call to action this spring to the entire California Community Colleges System. It is a collaborative effort amongst all divisions on campus. The Dr. Rodriguez, Interim Superintendent/President, emailed out a draft plan to the college. The draft plan was developed by Ms. Walker, Mrs. Moreno, and Mr. Singh which proposes actions that would help us advance in each area. The plan is to be used as a tool for the college to build upon and is not a finalized document. The Carla would like to see a conversation or work groups put into smaller groups.
