3. Fall Enrollment from Local High Schools

Dean Ceja shared the fall enrollment numbers from local high schools. The data is located on the council website for review. The data shows the last five years of enrollment starting with the 2017-2018 academic years. The numbers are consistent except for the last two years where there was a slight decrease in numbers. 4. Talent Search Presentation

Cesar Velazquez

Mr. Velazquez gave a presentation regarding Talent Search. The presentation is available on the council website for review. The Talent Search grant was recently awarded on October 1, 2021. He is in the process of hiring two program assistants. He hopes to have them hired by February to be able to implement the needed services. The Talent Search program identifies and assists individuals from disadvantaged backgrounds who have the potential to succeed in higher education. The program provides academic, career, and financial counseling to its participants and encourages them to graduate from high school and continue on to and complete their postsecondary education. Talent Search serves: high school students from low -income families and high school students from families in which neither parent holds a bachelor's degree. The goal of Talent Search is to increase the rate at which participants complete secondary education and enroll in and graduate from institutions of postsecondary education. 5. Proposed New Governance Structure

Ms. Yelland shared the proposed new governance structure outline with the members. The documents that were reviewed are available on the council website. Ms. Yelland stated the goal of the review is to seek feedback on the visual model draft based on the following desired outcomes: Governance System that is more student centered and/or more focused on improving student success System that is more organized and coordinated to avoid redundancies and working to cross purposes System in which the process & communication flow is clearer, more efficient, and more transparent. She shared a draft outline model that is a visual representation of the flow of the new governance model. This visual is a draft and has not been reviewed by the Governance Re-design task force yet. There will be a reduction to 4 councils which is down from 8 originally. All four councils are coordinated by the Governance coordination group that meets monthly by the tri leads of each of the four councils. It routes agenda items collaboratively and reports out to the governance system of the college. 10+1 items will be routed and approved at Academic Senate. Recommendations made to senior leadership, president/superintendent and the board of trustees. The coordination group will put out a monthly report available on the website for the public review.
