Background:

Title 5 provides the State Chancellor's Office authority to hold a district's enrollment (FTES) stable at a level reported prior to the occurrence of the emergency.

Requirements:

Districts must complete an application that shows:

- 1. Emergency Conditions Recovery Plan, adopted and approved by the local Board of Trustees and
- 2. Certification confirming that the District meets specific eligibility requirements.




