Instructions and DEADLINES:

- 1. All Out-of-State Students must submit a FAFSA for the 2024-2025 year <u>at least 3 weeks prior</u> to submitting their Petition for Delay of Payment Form to the Financial Aid Department.
- 2. Student must submit the Petition for Delay of Payment of Enrollment Fees form to the Financial Aid Department no later than 5:00 PM on the date of the **Spring 2025 Registration Payment Deadline**that applies to the student's registration period. *Please see Enrollment Fees Policy.
- 3. Any and all documents that are requested from the Financial Aid Office must be submitted no later than **January 14, 2025** to ensure that there is sufficient time to process the student's financial aid file.
- 4. Upon review of the student's financial aid file, the financial aid staff will determine the amount of the award the student is eligible for and record it on the Petition for Delay of Payment of Enrollment/Tuition Fees for Out-of-State Students form; or if not eligible for financial aid, it will be noted on the petition form.
- 5. The Financial Aid Department will then update the student's account to reflect the authorization of this request.
- 6. The student will be notified by email the status of their eligibility. It is the student's responsibility to follow-up with the financial aid office regarding the status of their request.
- 7. It is the student's responsibility to pay the following:
 - a. If eligible for federal aid, the student's financial aid award(s) will be applied to their balance. The student must pay the remaining balance by <u>March 14, 2025</u>.
 - b. If the student is not eligible for financial aid, the student must pay their outstanding balance by **January 14, 2025.**
