4.02 South County Meetings President Hernandez Discussion

This item is to approve the relocation of two meetings in the fall semester. Days to be determined.

There was a discussion to increase the number of monthly meetings in the South County.

Lupita asked if there could be open negotiations to have more than two meetings in the Fall semester to be held in the South County.

Jane said she, Seren, and Augustine had a private conversation, and that it wasn't too realistic to do it because technically Salinas is the main campus and the meetings have always been hosted there -- so, to try something like expanding meetings to other campuses would be something new, not realistic, and a drastic change.

However, a discussion can be raised and added to the agenda if any ASHC member makes a request to an executive officer or in a meeting discussion.

The item can be voted to approve more meetings in South County at any time.

October 14th might be one day an ASHC meeting will be held in South County for the grand opening.

Jane said technology is behind at the South County locations

Mr. Bursamino said we're going through unusual times.

David suggested that we have at least 1 South County meeting per month since things like gas, time traveled, and vehicle maintenance become a significant expense for people who already live in South County and have to commute to Salinas for every in-person meeting.

David and Seren agreed to take the initiative to expand the meeting location.

The discussion turned to vote upon the item to approve at least 2 meetings in the South County for the Fall semester:
